Part A: Pupil premium strategy plan

Statement of intent

At Poppleton Ousebank Primary School our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activities we have outlined in this statement are also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery, notably in its targeted support through the National Tutoring Programme for pupils whose education has been worst affected, including non-disadvantaged pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

Trust Vision and Rationale for Pupil Premium Strategy Life in all its Fullness - A Place to Thrive

Hope Sentamu Learning Trust is committed to enabling our communities to Thrive. To support all our learners and staff to flourish in high performing schools, to achieve and exceed their personal and academic potential. To transform life chances of young people, particularly the most disadvantaged and to transform our local communities,

through bringing the highest possible standards of education to our area. This strategy is underpinned by the EEF's three tiered evidence-based approach to Pupil Premium (teaching, academic support and wider approaches, to close the progress and attainment gap). First and foremost, great teaching changes lives. The core focus for all our schools will always be investment in the highest quality of teaching and learning for all pupils to further close the PP gap. It is to be read in conjunction with Hope Sentamu Learning Trust's 'Principles for Vulnerable Learners' and Audit Tool, which were developed in the Summer term of 2020, to further support key issues that disadvantaged pupils are currently facing in more benign times (such as gaps in learning, social isolation, mental health and wellbeing, motivation and aspiration, literacy), which will have been exacerbated by Covid-19. Furthermore, we need to anticipate an increase in the levels of disadvantage in all of our school communities, but particularly in those that experience the highest levels of disadvantage.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Assessments, observations, and discussions with pupils and staff indicate underdeveloped oral language skills and vocabulary gaps among children in our Early Years, particularly in our disadvantaged pupils.
2	Assessments, observations, and discussions with pupils suggest disadvantaged pupils generally have greater difficulties with phonics and spelling than their peers. This negatively impacts their development in reading fluency particularly in Years 1 to 3 and spelling in years 2 to 5.
3	Our attendance data over the last year indicates that some attendance among disadvantaged pupils is lower than for non-disadvantaged pupils. Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.
4	Our assessments, observations and discussions with pupils and families have identified social and emotional issues for some pupils. These challenges particularly affect disadvantaged pupils. Teacher and family referrals for support have markedly increased during the pandemic.
5	Internal assessments indicate that, for some, maths attainment among disadvantaged pupils is below that of non-disadvantaged pupils.

Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

Intended outcome	Success criteria
Improved oral language skills and vocabulary in Early Years	Assessments and observations indicate significantly improved oral language among children in the EYFS. This is evident when triangulated with other sources of evidence, including engagement in play, conversations with adults and peers and their ability to explain their learning/thinking.
Improved reading fluency attainment among disadvantaged pupils.	The increased fluency in reading enables pupils to engage with complex texts, exploring language, author intent and being able to follow more complex story lines to promote comprehension. Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2022 to 2023 academic year.

Improved oral language skills and vocabulary in Early Years

Communication and Language – 50% of children in receipt of pupil premium are making at least expected progress.

Next Steps

To continue to provide the children with rich learning environments with a range of language opportunities. To continue with Wellcomm in both Reception and Nursery as well as RWI and Time to Talk interventions. To place further TA support in class to support language development.

Improved reading fluency attainment among disadvantaged pupils.

Reading – 80% of children in receipt of pupil premium are making at least expected progress.

Reading – 56% of children in receipt of pupil premium are achieving at least in line with age related expectations.

Next Steps

To continue with the RWI programme throughout the school - fast track and Phonics interventions for targeted children as well as daily reading with volunteers.

Improved spelling attainment among disadvantaged pupils.

Writing – 73% of children in receipt of pupil premium are making at least expected progress.

Writing – 45% of children in receipt of pupil premium are achieving at least in line with age related expectations.

Next Steps

To continue with RWI interventions and daily spellings for those highlighted for targeted support.

Improved maths fluency in attainment for disadvantaged pupils.

Mathematics – 83% of children in receipt of pupil premium make at least expected progress.

Mathematics – 58% of children in receipt of pupil premium are achieving at least in line with age related expectations.

Next Steps

To continue to promote maths attainment and interventions for those who need additional support. Maths lead to support staff in school with curriculum delivery if required.

To achieve and sustain improved wellbeing for all pupils in our school, particularly our disadvantaged pupils.

Pupils live up to the high expectations that leaders and staff have of them. By the end of Year 6, all pupils, including disadvantaged pupils and pupils with special educational needs and/or disabilities (SEND), are prepared well to make the best possible start at secondary school.

Many pupils, including disadvantaged pupils and pupils with SEND, participate in the wide range of clubs on offer. Opportunities to perform and compete are plentiful. This allows pupils to develop their interests and talents in arts and sports.

Key Stage two children are involved with becoming Wellbeing ambassadors, they run clubs for children at lunchtime and provide support if required.

All children have access to the WBIM Team, our school ELSA and wellbeing advisors.

Next Steps

To continue our universal offer to all children, to promote wellbeing throughout the school. Promote the HAF activities and in school activities for all children.

Additional activity

Our pupil premium strategy will be supplemented by additional activity that is not being funded by pupil premium or recovery premium. That will include:

- embedding more effective practice around feedback. <u>EEF evidence</u> demonstrates this has significant benefits for pupils, particularly disadvantaged pupils.
- utilising a <u>DfE grant to train a senior mental health lead</u>. The training we have selected will focus on the training needs identified through the online tool: to develop our understanding of our pupils' needs, give pupils a voice in how we address wellbeing, and support more effective collaboration with parents.
- offering a wide range of high-quality extracurricular activities to boost wellbeing, behaviour, attendance, and aspiration. Activities will focus on building life skills such as confidence, resilience, and socialising. Disadvantaged pupils will be encouraged and supported to participate.

Planning, implementation, and evaluation

In planning our new pupil premium strategy, we evaluated why activity undertaken in previous years had not had the degree of impact that we had expected. We also commissioned a pupil premium review to get an external perspective.

We triangulated evidence from multiple sources of data including assessments, engagement in class book scrutiny, conversations with parents, students and teachers in order to identify the challenges faced by disadvantaged pupils. We also used the EEF's families of schools database to view the performance of disadvantaged pupils in schools similar to ours and contacted schools with high-performing disadvantaged pupils to learn from their approach.

We looked at a number of reports, studies and research papers about effective use of pupil premium, the impact of disadvantage on education outcomes and how to address challenges to learning presented by socio-economic disadvantage. We also looked at studies about the impact of the pandemic on disadvantaged pupils.

We used the <u>EEF's implementation guidance</u> to help us develop our strategy, particularly the 'explore' phase to help us diagnose specific pupil needs and work out which activities and approaches are likely to work in our school. We will continue to use it through the implementation of activities.

We have put a robust evaluation framework in place for the duration of our three-year approach and will adjust our plan over time to secure better outcomes for pupils.
